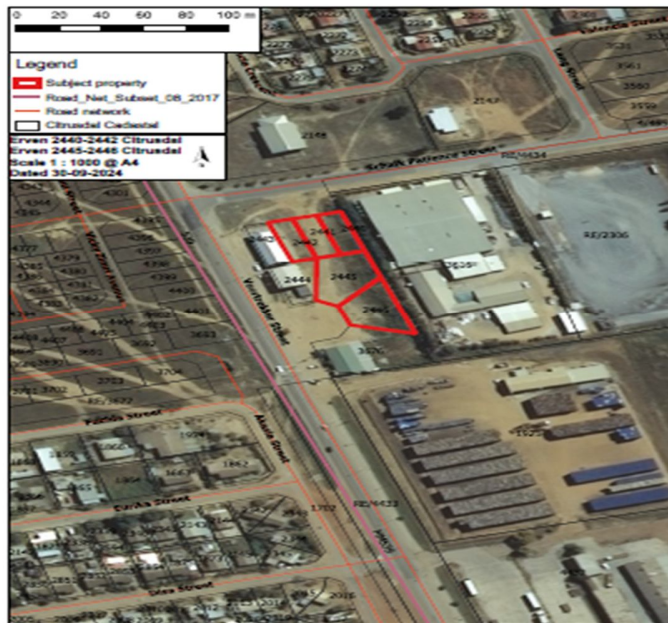
Tenders are hereby invited for the abovementioned "ALIENATION OF ERF 2442, CITRUSDAL."
